Peter Rodham, Property & Building Projects from Northern Beaches Council (NBC) introduced himself as the Project Manager and welcomed everyone back after the working group had been put on hold with COVID-19 project delays, also welcoming new members.

An update was provided on the projects history and progress. In summary, Covid-19 put a hold on the project in 2020 with consultants engaged in 2021 for planning, engineering, environmental and other investigations. These findings were bundled up and Design Consultant procurement occurred with TERROIR Pty Ltd being appointed in 2022.

P Rodham provided the Group with a summary of feedback collected during the initial engagement stage, as well as an overview of the engagement activities in December 2022. These items in summary are:

# Design:



- An iconic design that people will travel to see
- Something that compliments its natural surroundings

#### **Environmental:**

• Some concerns that a new club will have too great an impact the surrounding environment

#### Commercialisation:

 Mixed feelings: many supportive comments about a restaurant/bar, whilst others don't support any commercial aspects

The group were informed of the current committed project budget of \$11M, with the hope of obtaining additional funds. The current budget will impact the facilities that are able to be provided.

TERROIR provided a presentation on the findings of the site constraints and opportunities, showing schematic designs including the potential building inclusions for the Surf Club, professional Lifeguards and public amenities (toilets). This included a version with the public amenities as a separate building slightly to the north (exact location not determined).

The group was advised of the proposed timeline as below:

## Phase 2 (Building Locations):

Finalise outcome after Club and Community Working Group meetings

#### Phase 3 (Concept Designs):

- Finalise concept designs with relevant inclusions this year.
- Includes further public community engagement events and Community Working Group meeting.

# Phase 4 (DA):

DA submission, exhibition and determination in 2024

# Phases 5 – 7 (Detailed Design, Procurement, Construction Cert & Construction):

• Finalise design documents and open tender to the market for construction services, Builder engaged and works occur onsite, completion 2026.
