
1. Summary

This report outlines the outcomes of community and stakeholder engagement as part of a proposal to upgrade the existing Michaela Howie playground at Dee Why Beach.

The feedback collected during consultation indicated a high level of support for the proposed upgrades, with comments proposing alternative design suggestions and enhancements.

Respondents who were not supportive of the proposal raised concerns about the environmental impact of synthetic grass, and another suggested upgrading the playground at James Meehan reserve instead.



2. Background

Michaela Howie Playground is a popular District playground situated in the prime location of Dee Why Beach Reserve.

Council has allocated budget for the renewal of the playground to provide new play equipment, surfacing and associated landscaping within the current footprint.

A concept plan was developed by Council's Parks Asset Team to provide an indication of the proposed renewal for Community Engagement.

The Concept would be refined after Community Engagement and prior to undertaking procurement for the works.

3. Engagement objectives

Community and stakeholder engagement aimed to:

- Build community and stakeholder awareness of participation activities.
- Provide accessible information so community and stakeholders can participate in a meaningful way.
- Identify community and stakeholder concerns, local knowledge and values.
- Seek out and facilitate the involvement of those affected by or interested in a project.
- Communicate to community and stakeholders how their input was incorporated into the planning and decision-making process.
- Provide vulnerable and marginalised groups access to the engagement process.

4. Engagement approach

Community and stakeholder engagement for the Michael Howie Playground renewal was conducted between 4 April 2023 to 7 May 2023, and consisted of a series of activities that provided opportunities for community and stakeholders to contribute.

The engagement was planned, implemented and reported in accordance with Council's Community Engagement Strategy (2022).

A project page was established on our have your say platform with information provided in an accessible and easy to read format.

The project was primarily promoted through our regular email newsletter (EDM) channels.

Feedback was captured through an online comment form embedded onto the have your say project page. The form included a question that directly asked respondents for their level of support on the proposal.

An open-field comments box provided community members a space to explain or elaborate on their support, not support or neutral sentiment as well as any other feedback they wished to contribute.

As well as the sentiment question and free text, a rating tool was used to ask participants to rate the importance of the following elements of play:

Natural features



- moving elements (swings, springs, spinning)
- quiet places
- accessibility
- imaginative play
- challenging climbing
- group play
- toddler play equipment.

Email and written comments were also invited. Two written responses were received via email.

5. Findings

The majority of respondents were pleased that the playground is due to undergo renewal, however it seemed that many people had higher expectations with a feeling that the playground would benefit from a complete redesign and expansion.

34% of respondents supported the project and 61% supported, however would also like to see some changes. Only 2 respondents (4%) did not support the project.

There were multiple requests for types of play equipment and examples of playgrounds that were at a much larger scale and budget to Michaela Howie Playground.

There were also requests for more nature play, natural elements, seating and to cater for a greater age range.

The quantitative results showed a preference for moving elements, imaginative play, natural features and challenging climbing.

These findings will guide the revision of the concept plan. All community requests may not be suitable for the size, budget and location of Michaela Howie Playground, however these findings will be taken into account with the development of the whole precinct and future renewal of James Meehan Reserve Playground.

suburb with more families occupying units and townhouses with no gardens or play areas. The increasing demand is overwhelming the severely limited shared open spaces. The beachfront is currently the suburb's only significant outdoor area where families can access nearby amenities whist enjoying the outdoors and this playground is a key facility with enormous demand from a broad community. The redevelopment of Michaela Howie Playground is a significant opportunity that should not be squandered. The former Warringah Council repeatedly fell short of other Sydney councils when it came to developing playgrounds, public spaces and street furniture, with many of these amenities failing to endure with public use. Northern Beaches Council needs to create a sustainable, natural, imaginative and modern space which engages and challenges children.

With regards to the 'ranking' of play elements, with accessibility being one of these, the nearby playground at James Meehan Reserve has greater scope to expand to incorporate more accessible features and equipment. Group Play is also listed for ranking and some playground equipment which facilitates this, such as a cubby house, are better suited to the space that James Meehan Reserve has. INNOVATION: discover fresh ideas and design features which are DIFFERENT to other local playgrounds to provide interest and variation which will stimulate children. Research other playgrounds which have achieved excellence in these areas and build on their best qualities. Eg: in-ground trampolines, merrygo-round, spinning chair, sit-on diggers, horizontal climbing net, musical instruments. Our kids deserve a playground akin to the inclusive play space that is Paperbark Playground in Parramatta Park.

NATURE OASIS: incorporate garden beds with unique and interesting flora which children can actually interact with and grow their appreciation of nature. Introduce a shallow flowing creek in which children can cool off, get wet. Have a water pump feature for the industrious. Include some nature play elements such as wooden logs to walk across and stepping stones. Make use of the existing sloped areas to provide a ride-on or scooter path around the perimeter.

CHILD DEVELOPMENT: play equipment should challenge children's motor skills and muscle strength, and promote self-confidence, emotional resilience and invoke a desire to challenge themselves. Bring back the see-saw = balance, communication, coordination & physics!

SENSE OF TIME & PLACE: Stimulate children's minds and curiosity. Include some history of Dee Why beach front with photographs of the area to provide a sense of the change that has occurred to the natural and social landscape in the last hundred years. This history should be incorporated to shape some of the landscape and structural elements.

BEAUTY & SUSTAINABILITY: finishes of all materials used should be their original natural colours, with no painted surfaces, to be sustainable, reduce maintenance and most importantly, blend with and compliment the environmental beauty of the beachfront. eg: don't paint existing shade cloth poles - the metal/steel finish is good and doesn't require repeated coats of paint! Children's surroundings have become excessively stimulating and disrupting with the cacophony of colours in toys, play centres, preschools, shopping centres and playgrounds. It's a visual bombardment which overloads their senses, which creates a stressful environment. A new approach to this playground can disrupt this barrage of rainbow and gelato colours.

PS: the feedback form is poorly designed doesn't demonstrate knowledge of questionnaire design to gather quality feedback. It asks for age range but then also year of birth which will succeed only in gathering worthless invalidated responses.

Please ensure ground cover and equipment is suitable for direct sun where applicable, current black floor cover and red slide are unusable in the sunshine from about 10am Often along wait for toddler / baby swings

I love the theme iconic childhood surf and beach but I'm not in support of the ice cream and gelato shop. Imagination is the best part of play, would be great to see a generic shop where children can sell sushi, surf boards or something else. Why specify and limit their imagination of what they can sell to gelato. Ice creams are fun, but I feel this is not supporting healthy eating, it's already everywhere and the evidence of the damage of exposure and what it does to your health is clear. Could we replace the ice creams with shovels, strawberries, sushi or something else that is fun? Museum of Arts and Applied Sciences previously did a theme being Gold Coast and their artist designed a Tourist shop for children to use as imaginative play.

2	Dear Phillip I read with interest the proposal for the Playground renewal and have a few suggestions. 1 - Rubber softfall surface: There is frequently a missed opportunity to provide a design that actively engages the user experience such incorporating within the design a themed hopscotch, maze, labyrinth, line (to walk along), or pictures ie starfish etc close enough that children can jump between them. 2 - Synthetic grass - can a strip of this be extended within the playground to form a path that can take a meandering shape to provide interest, visually connect the spaces and again provide a level of interactivity on the floor space. 3- Include passive wooden pieces that children can use for imaginative play and are climbable such as wooden stumps of different heights on their ends as well as logs raised ever so slightly. These are ideal for perimeters of the playground. Great examples of this are at the Waringah Aquatic centre in the outdoor play area. 4 - Mini trampolines inset into the ground such as at the Narrabeen playground next to the Tramshed Cafe.
