## 1. Summary

This report outlines the outcomes of community and stakeholder engagement as part of a proposal for the renewal of the Paradise Beach jetty and tidal pool at Paradise Beach, Clareville / Avalon Beach.

The feedback collected during consultation indicated a high level of support for the proposal, citing their overall fondness and enjoyment of the pool and wishing to guarantee its longevity.

The small number of respondents who were not supportive (5) raised concerns that the location is not optimal for this style of infrastructure.



## 2. Background

The Paradise Beach wharf and pool is a much loved community facility. Built in the 1940's, the current structure is at the end of its life and requires a complete rebuild. The proposal to rebuild the structure presents an opportunity for Council to improve the amenity further to include beach shower and foot tap.

Due to the heritage listing and surrounding seagrasses, the footprint and aesthetic of the structure will be retained with some improvements. The proposed design also incorporates a living sea wall which has been shown to significantly increase the ecological biodiversity of artificial structures in a marine environment.

The structure has deteriorated, and this continues to pose increased risks, hazards, and challenges for Council. Further to this, the structure is too low and goes completely underwater in higher tides. A complete re-build is considered the most appropriate option to appropriately address increasing safety concerns and accelerating maintenance costs.

In line with Transport for NSW's (TfNSW) Boating Now program the jetty/wharf will see some improvements for access to the waterway for users. Council has received some funding for the design of the jetty/wharf through this program.

## 3. Engagement objectives

Community and stakeholder engagement aimed to:

- build community and stakeholder awareness of participation activities.
- provide accessible information so community and stakeholders can participate in a meaningful way.
- provide balanced and objective information to assist in understanding the problem, alternatives and/or solutions.
- identify community and stakeholder concerns, local knowledge, and values.

## 4. Engagement approach

Community and stakeholder engagement for the Paradise Beach Jetty and Tidal Pool Renewal was conducted between 8 June 2021 and 28 May 2023 and consisted of a series of activities that provided opportunities for community and stakeholders to contribute.



The engagement was planned, implemented and reported in accordance with Council's <u>Community Engagement Strategy</u> (2022).

Avalon Preservation Association (APA) and Clareville and Bilgola Residents Association (CABPRA) were involved early on to assist with the development of concepts and optioneering. This was in the form of in person and online presentations followed by discussions. Some long term residents living adjacent the pool were consulted in person on a range of issues, helping to inform concept planning and scope.

A final presentation and discussion forum for the resident associations was held at the Avalon Community Centre on 9<sup>th</sup> March 2023 prior to the Your Say web engagement to the wider community.

A project page was established on our have your say platform with information provided in an accessible and easy to read format. The Your Say engagement ran from 1 May 2023 to 28 May 2023.

The project was primarily promoted through our regular email newsletter (EDM) channels.

Feedback was captured through an online submission form embedded onto the have your say project page.

Email and written comments were also invited with (4) four submissions made via this platform.

### 5. Findings

97% of the respondents were in favour of the proposal. 70% were in favour with no comment and 27% suggested some changes. 3% of respondents were not in favour.

The results indicate a strong community viewpoint that the pool and wharf be renewed generally as per the proposal.

Most of the feedback involved comment on the current management of the beach and surrounding parking areas which was outside the scope of the consultation. The consultation report will be forwarded to the Parks and Coastal Teams for review and consideration.

Of the small amount of feedback received relating directly to the design of the pool, wharf and groyne, concerns were raised about disabled access to the pool, the reduction in the size of the groyne length and increasing the width of the wharf and groyne. A couple of responses indicated they did not want the wharf lifted in height.

54% of respondents were in support of a shower as proposed with 11% against and 35% unsure. There was a polarisation of views amongst residents residing near or adjacent the beach and those who did not. The nearby residents expressed concern about the shower location impeding sight lines, the provision of water encouraging anti-social behaviour, excessive dog presence, nudity, and other issues. Those in support also requested toilets.

As the provision of a shower is outside the scope of this work, the findings will be provided to the Parks team for consideration as to whether the shower would be funded or not. Final decision on this issue will be by the Parks team as the asset owner and manager of the area.

Based on the feedback it is not proposed to alter the proposed design of the wharf/pool and jetty. Council will seek costings in the tender process to keep the groyne the same length. A decision will be made in the post tender review phase whether to maintain the current groyne design or extend it to its current length.

Council has received expert advice that reduction of the groyne as planned will not affect sand movement on the beach. We note the concerns and will review the options and cost for maintaining the groyne length in the tender process.

During the consultation/exhibition, Council received a number of questions either through direct contact or within feedback received.

Question raised in feedback	Council's answer
Where is the REF?	The Review of Environmental Factors (REF) reviews the impact of the design. When the design is finalised, the REF can be completed. Parts of the REF including seagrass mapping have already been completed as they were necessary in the optioneering process. Some consultation has already occurred with the Fisheries Department, for example, the pool cannot be made deeper due to the presence of Posidonia seagrass.
Where is the ramp and disabled access to the pool?	A tidal ramp is not recommended in current standards for marine structures. Accessibility was considered in the concept optioneering process with considerable barriers identified. We note the feedback and will consider further investigation of options for inclusivity in the design.
Where are you relocating the seahorses?	Any seahorses found prior to the works will be relocated as per the NSW Department of Fisheries permit conditions. This may include relocation to nearby Posidonia sea grass beds or artificial sea horse hotels installed prior to the construction works. The REF and seahorse relocation plan are yet to be completed. They will be finalised when the design is complete.
