# 1. Summary<sup>1</sup>

This report outlines community and stakeholder engagement results from the public exhibition of the Commercial Centre Upgrade, Forestville.

The community consultation revealed that the majority of respondents were supportive of the proposed landscaping improvements to The Centre at Forestville.

Many comments, however, requested slight modifications to the design to generally improve access and minor design inclusions.

A key issue raised was relating to the width and length of the proposed garden beds restricting the outdoor dining space, which some believed may negatively impact restaurants and cafes.


More seating was generally supported with some concern raised regarding design and placement of seats in the shopping precinct. There was a mixed response to the type of lighting proposed.

The proposal to investigate the construction of a permanent public amenities facility at a later date received considerable support.



### 2. Background

A key part of making the Northern Beaches a liveable, vibrant and connected place is making our commercial centres attractive for business and visitors.

In May 2018 Council commissioned Placescore to survey 14 town/villages across our local government area, asking the community what they value most about their local village or commercial centre and how certain attributes such as cleanliness, maintenance, natural environment or night time economy were performing.

The results of the Placescore survey showed that the community's top two priorities for The Centre, Forestville were enhancement of the natural environment and maintenance of public spaces and street furniture in and around the shopping area.

Based on these outcomes, concept designs were developed to improve the landscaping within the shopping precinct, including new seating, lights, bins and bollards as well as widened garden beds and grass in the central meeting area.

## 3. Engagement objectives

- Build community and stakeholder awareness of participation activities (inform).
- Provide accessible information so community and stakeholders can participate in a meaningful way (inform).
- Identify community and stakeholder concerns, local knowledge and values (consult).
- Gauge local appetite for the construction of a permanent amenities block sometime in the future.

# 4. Engagement approach

The Commercial Centre upgrade, Forestville community engagement was planned, implemented and reported in accordance with Council's <u>Community Engagement Matrix</u> (2017).

Project information and an opportunity to provide feedback was included on the Councils Have Your Say project page. Behavioural economics principles guided the development of the online content to ensure clear and consistent information was provided to our community. A concept plan was used to support the page content.

Feedback was primarily collected through an online comment form with email and written responses also accepted.

To promote the engagement to visitors to the shopping area, signs were installed in prominent areas around the shops and a meeting with the local businesses was held on Wednesday 23 September 2020.

The project was also promoted through the Community Engagement Newsletter and Council eNews.

# 5. Findings

The vast majority (85 percent) of comments were supportive of the concept design to make landscaping improvements to The Centre at Forestville. Many comments spoke about The Centre being in desperate need of renewal and others thought that the proposed concept



didn't go far enough and they would like to see greater refurbishment of the shops and pedestrian area.

Some comments indicated that they would like slight modifications to the design such as reduced garden bed size, synthetic turf not natural turf and flexibility around seating spaces to ensure outdoor dining is accommodated.

There was a strong thread running through the comments of the desire to support local businesses and respondents wanted the landscape improvements to reflect this. A few of the comments regarding the proposed wider planter boxes were concerned that the size of the beds would narrow path width and impact on available outdoor dining space currently being utilised by local businesses.

More seating was generally supported, but there were numerous comments about the design and placement of seats in the shopping precinct.

There was a mixed response to the proposed pole and catenary lighting, with some responses indicating gentle lights would improve the atmosphere and dining ambiance, while others felt the choice of lighting appeared cheap.

The proposal to investigate the construction of a permanent public amenities facility at a later date was supported by 86 percent of respondents.

The key themes from the comments are listed and summarised below.

Theme	What we heard	Response
Public toilets	General support for building a permanent toilet block in the carpark sometime in the future, with many comments saying the construction of public toilets should be a priority and not delayed further.  There were some comments that raised concerns about the impact on car parking spaces if a new amenity block was built in the carpark or that it is not necessary as the current Exeloo is adequate and there is an existing toilet in the Community Arts Centre.	Although out of scope for the current project, this feedback will be used to inform future engagement if the project progresses (subject to future grant funding).
Seating	Responses on the proposed seating were positive with many agreeing there is a need for more seating and commenting on the preferred design.  Several comments suggested more outdoor dining in general, with separate tables and seats rather than integrating the seating with the planter boxes.  Other comments wanted to see no change in the seating, with concerns that it may impede access or compete with the cafes' seating.	These comments will be considered in the design review.  The static seats built in the garden beds are designed to be used for outdoor dining in some cases.
Lighting	There were mixed feelings about the lighting. A few comments thought that catenary lighting would add atmosphere	A lighting consultant is reviewing the specifications to ensure



	and 'vibrancy' of the cafes while others felt the lights would look 'untidy' and 'cheap'. There were suggestions for coloured and LED lighting.	the lighting scheme is of high quality commercial grade to enhance night time activation.
Planter boxes Pedestrian Access/flow	A considerable number of comments were about the size and position of the proposed widened planter boxes.  While there was general support for planter boxes and increasing the greenery of the area, there were concerns that the increased size of the garden beds would impact pedestrian access and flow through the pedestrian zone.  Other comments felt that larger garden beds would restrict the area for outdoor dining which would adversely affect the cafes and restaurants.	The design will be reviewed following the feedback in order to achieve a balance between garden beds being large enough to accommodate tree growth and the need for space and access for pedestrian.
War Memorial	Feedback indicated the need for more information regarding the plans for the existing war memorial.  Whilst some respondents would like to retain the memorial, others feel that the space could utilised for outdoor dining.  Council also received a suggestion to relocate the memorial locally.	To be considered in the design review and in consultation with the RSL.
Grass and vegetation	The proposed new grassed area met with mixed responses in the comments.  Many liked the concept of a grassed lawn area, however, several respondents felt that because of high pedestrian activity, the grass would not last and the area would turn into a 'dust bowl'. Other materials were suggested as alternatives, such as synthetic grass, paving or another non-reflective surface.  Multiple comments questioned the choice of proposed and existing plant species in the garden beds, with suggestions for large shade trees, use of natives and inclusion of flowering plants.	To be considered in design review.
Play equipment	The inclusion of children's play equipment or a small playground in the central gathering area.	There is insufficient space to accommodate this in the memorial area of The Centre. There is a playground at the Community Arts Centre.
Bins and bollards	The placement of rubbish bins was mentioned a few times in the comments.	Comments noted.



	A couple of respondents would like seats outside the toyshop for waiting parents, rather than rubbish bins.	
	A few comments thought that new bollards were a good idea as a safety barrier at the carpark, while one thought they could be an opportunity for public art.	
Additional Facilities	A few respondents mentioned that they would like bike racks, dog tie up areas and a drinking fountain included in the design.	To be considered in design review and will be catered for.
Non-support (general themes)	The reasons given for not supporting the proposal included that it was small scale and short sighted.	
	Some felt the centre hadn't changed in years and the area needed major upgrades. Others thought it needed a wider urban planning approach, with a design made to meet the future needs of the area.	
	A small number of respondents felt the proposal is a waste of money and the precinct didn't need upgrading.

No.	Comments
1	Too many rumours floating around about redesigning the Forestway site. I would like to hear wait before making a choice.
2	We have the library toilets which are maintained very well. If their usage hours are maintained or better, increased, then why duplicate for an inferior outcome
3	Great concept designs! Love the proposed improvements to community spaces. One detail I can't see are any additional spaces for securing bikes. I try to reduce use of our petrol car as much as possible by riding with my kids for short trips to the local village at The Centre. When I do ride bikes, there are very few spaces to secure our bikes. Can more bike racks be added so our bikes can be secured in front of relevant shops safely?
4	The only change I would suggest is to the central square, which is shown in the plan as a lawn. It should contain a water feature, such as a pond with a fountain in the centre, as a refreshing, cooling device for this area which can be hot in summer, and containing comfortable seating; this could become a popular meeting place for gatherings, as well as to meet friends. Please also retain the war - and soldier settlement - memorial and flag post here as an important reminder of local history. A lawn here may not be very practical, but it is worth trying!  Along the walkway, do not replace the existing trees or planter boxes - the arrangement works well, provides pleasant seating and shade, and the foliage is healthy and attractive. The pavers are perfectly suitable. I do not like the proposed new lighting - these random "fairy lights" look untidy. Perhaps a few extra lights on poles matching the existing ones would be helpful and contribute to a safe and attractive space for evening strollers. Otherwise, the Centre at Forestville is an excellent example of urban planning - I have been coming here for 23 years, I enjoy the space and its community feel every time, and it does not need any further updating, apart from my two suggestions, above.
5	well over due project, particularly the toilets
6	Hi I think keeping the chinese tallowoods is a mistake their roots will continue to destroy structures planters and paving as they are nowhere near being mature. The birds make a mess of them and the leaf and flower drop must be a maintenance nightmare.  Havent read the detail completely but I hope the "lawn" is actually artificial grass as opposed to the real thing as it wont last 2 seconds with the wear and tear that this area of the centre strip gets.

8	The concept and the project sounds really good, but I don't think the garden beds need to be widened ,as it would make the pathway narrower. - 12 1. Please retain the existing mature trees and provide some native plantings.
  - 2. Provide some type of barrier in the garden beds as many dog owners tie their dogs to the trunks and the vegetation is damaged. More dog tie-up facilities would help (like those outside Coles)
  - 3. New seating be of a material that does not become too hot to sit on; metal seats can get too hot on 30+ degree days.
  - 4. Provide artful signage in the mall to the Forestville Library, Forest Community Arts Centre and public toilets (the existing signage is insufficient and the pole is displaced)
  - 5. Provide an accessible public notice board within the mall. This will help stop public notices defacing shop walls and light poles.
  - 6. Provide better signage warning "no bike or skateboard riding in the mall". (Many young people do this which is a danger to some people.)
  - 7. I am against a larger public toilet block in the carpark. For more than 10 years I was a Council Community Centre Manager in the local area and am aware of the many problems associated with the demolished old brick public toilet block, including it being a known meeting place for casual sexual encounters, even in daylight. The then local Community Centre Management Committee discussed this topic at length many times.

I believe the solution is to provide a second small toilet amenity (such as the existing one at the end of the laneway) but in another easily seen location in the village, for the use of restaurant diners when the Library and Arts Centre is closed.

### 13 Re the WW1 Memorial.

- 1. The design plan says very little about the new memorial except "new memorial on raised plinth" (Page 4.2 dot point 5) and "Option for memorial sculpture" (Page 6.1 "Materials" where it shows an artist's impression of a cylindrical "cage", floodlit and surrounded by paving".
- 2. The siting of the new memorial is in a new position, the current memorial site now having a tree and seating.

Before I could agree with this aspect of the plan I would want to know that the new memorial incorporates the sentiment and spirit of the old (flagpole, commemorative plaque and specific wording on the plaque).

I would want to be assured that the memorial continued to "honour the Men and Women of the Armed Forces" (etc as on the current plaque) and that the siting of the memorial recognized that the Forestville Shopping Centre was the area on which the original Soldiers Settlement of 1916 was established.

I would not want the memorial site moved, as it is proposed, as currently the site was determined after much deliberation (in 1998) as the central point of the shopping centre, visible from all directions, and not (as seems likely) to be moved to one side in favour of a tree and seating.

I understand that the RSL at Forestville has agreed with the plans but this approval has been objected to on the basis that the RSL could not have seen detailed plans of what is intended (there are none) and the fact that the memorial is to be moved was not understood.

We must also remember that the Governor Sir Gordon Samuels dedicated the memorial in 1998 and so the memorial, its flagpole, the plaque, the wording on the plaque and the specific site have the highest approval and these aspects are of historical importance.



- I am all for providing more green spaces and places for people to sit and relax. However I believe the current plan will reduce the space for people to walk through The Centre from one end to another as they will be required to move through the spaces in front of the retail areas where outdoor dining currently exists.
  - I believe to build a thriving community centre, more thought needs to be given to the outdoor spaces that can be used in retail, such as covered areas for restaurant seating and appropriate night lighting to encourage more vibrancy in the cafes and restaurants. Retailers such as Tilt, Michel's Patisserie, the Japanese restaurant, Forest Brunch Bar, Lucky's and Peps Pizzeria and the fish and chip shop all have outdoor seating in areas that seem to be, in the new plan, taken up by garden beds and casual seating. I am all for playground areas being provided for children, however I would want this area to be adequately maintained and suggest either fake grass or the rubber surface be provided for this rather than real grass, which I have heard turned to dust and dirt when previously located in The Centre.

I acknowledge that the staircase from the carpark below Coles is owned by that retail space, however the plans do not address the lack of access from the car park to The Centre, or lighting down the ramp next to Coles towards the back carpark. It would be good to see more wide access given from the car park. It has been particularly difficult to social distance in the stair wells in 2020, and better lighting needs to be provided.

I am totally against removal of the Memorial Seat and flag pole at the Forestville S/Centre as shown on the new draft Plan. It is being replaced by a tree. As a member of the Forestville RSL sub-Branch I was requested to design a memorial with Flag pole in 1997. The memorial was to the returning servicemen from World War 1 and their struggle to build in the bushland of French's Forest, then known as Soldier's Settlement - now Forestville. This memorial site was portion 1251 and was originally owned by James Little 24/4/1916 and the first transfer officiated by the then Governor General. Mr Little had just been discharged from hospital after service in Gallipoli.

With the support of the Deputy Mayor and many Councillors approval was given by Warringah Council and built with my supervision. The Governor General Gordon Samuels AC dedicated this memorial on 27/6/1998. Please note the Memorial's existing position.

- (1) Keep clear for pedestrian traffic
- (2) Most importantly the Memorial Flag pole and Australian Flag is in a position where it is in view to shoppers between Starkey Street and Darley Street and the flag and light can be seen by all at night.
- (3) The four plagues are in a position for children to observe.

Looking at the draft proposed plans the Memorial and Flagpole with Australian flag are hidden from view and cannot be seen unless you are in front of it. This is a total waste of ratepayers money to remove and then rebuild a Memorial.

I am totally against removal of the dedicated Memorial Seat and flag pole and will speak at the sub-branch meeting on the 2nd December as no one on the committee of the sub-Branch know the full history of the Memorial and I should have been in the discussion .

- There was previously a lawn area which was very hard to maintain and so was removed. Dry in summer, wet when heavy periods of rain, worn areas where people walk through Artificial lawn could be used to provide greening effect, however consideration must used because this can also become slippery when wet or heavy dew.
- Yes clean facilities are required, the current toilets are unacceptable for a shopping centre like The Centre at Forestville. The Community Centre toilets are great but are closed after hours.
- 18 Public toilets are a must

I would like to see the staircase under the Coles supermarket lift car park improved. It is way way to narrow. Particularly noticeable in these COVID times, I could never understand why it was built so narrow given how much use it gets. In comparison the ramp is very underutilized .



19	The boxing around the trees will be too big and will take away outdoor seating from cafes. We are supposed to be supporting the businesses as much as we can but the businesses will lose out if you take away outdoor seating space
20	Dear Sir/Madam, I would like to comment about the new bin (number 10). That area is a little spot for us (parents) to look into the shop ABC Kids Paradise and look at our children decide on what toys they want as well as a sitting and resting area for us to talk. Could you please move the bins to a different place. Thank you,
21	The size of the garden beds are big enough all they need is to be maintained by Northern Beaches council staff at times the gardens can look run down.  Another thought ask for volunteers to help maintain the garden landscaping.
22	<ol> <li>The planter boxes should remain with the bullnose style bricks and rounded corners for public safety, kids play jump run and ride in the area and head injuries are lessened in a fall if sharp corners are minimised.</li> <li>Build a second deck to the outside car park with a roof covered in solar panels for EV charging.</li> </ol>
23	Amenities block is desperately needed. I always went to other shops with my kids due to the lack of amenities (library and public toilet not sufficient). Whilst the landscaping looks amazing, the buildings still look old and tired and there are many empty shops. Compared to other shops in the area (Glenrose, new planned Forestway) Forestville shops are disappointing. I know it is challenging as I imagine they are individually owned. I think a further investment is required to bring the shops into the modern day.
24	The bathroom is very much needed!
25	Looks great nice seating and plant areas. Love the glass area in the central area. Would absolutely love a toilet block. The current toilet facilities and seating is poor. Thanks for the upgrade.
26	I like it
27	Toilet blocks should be a priority
28	The toilet block is desperately needed but instead of removing car parking spots could it not be built into one of the many vacant shops?
29	It would be good to have a permanent toilet block closer than the library. The one near the post office is awful.
30	Bigger Public Toilets would be great.
31	The stairwell from Viles to the underground car park is so dirty and old. It's needs proper cleaning and painting. The shopping precinct needs modernising along the lines of Glenrose shopping experience. Forestville is so out dated and tired looking.
32	This is pretty important. The bathroom facilities have long been inadequate. I love this community shooing centre. It needs a tidy up and we the community need to but snd support local so that we continue to have these businesses open for us.
33	The actual issue is the shipping precinct itself. The whole mall and surrounds needs to be redeveloped. This can't be kept being out off, we need council to prepare a rezoning plan to allow a developer to completely rebuild the entire site, from Darley to Starkey. Run a design competition to ensure we get a great outcome with a mix of retail commercial and residential as well as community services space.  Simply revamping the mall is just kicking the can down the road.



34 Dense and tall landscaping down the middle of the shops can block line of sight which is annoying when you are shopping and searching for services. Please provide seats of varying heights and with back supports as the elderly can't "perch" easily on hard surfaces like brick walls nor on wooden benches without back supports. Many of the shoppers are seniors and it would be great to cater for their needs. 35 Just worried that by extending the current flower beds that the gap between the flour beds and shops will become very tight! I currently worry when the young faster people try push past the older slower pedestrians... 36 I'm wondering why new bollards are required? Could that be some money saved? I think some of the budget needs to be put towards the ongoing maintenance and cleaners. The paving is often so grotty and bins overflowing. Also suggest better/more signage about 3 hour parking limit because I think many visitors exceed the time limit. Or designate the lower level of the carpark under Coles as unlimited time for commuters, but everywhere else is 3 hours max. 37 In addition to the grassy meeting area I'd like to see something for families with young children. Eg a small play structure. Also, more al fresco Dining of an evening would lift the whole suburb and be great for local economy Years ago there was a grassed area which was gradually covered with concrete as it was 38 a dust bowl where people walked. Also if gardens are made bigger there won't be space to walk as outside most shops the owners put so much stock on the paved area it's difficult to get passed people on a busy day or if it's raining. Save your money and spend it elsewhere. On the memorial hall garden maybe. 39 A central (fenced) playground and outdoor dining areas would be great. - Better traffic flow around that area would be nice. Especially morning and afternoon peak. A designated left turn lane/on ramp onto Warringah road from starkey/darley or other parallel road would help. As well as enhanced access to coles underground car park from starky street 40 A proper amenities block should be built prior to anything else. What is there at the moment is a disgrace particularly in this modern era of providing appropriate and proper amenities for shoppers who cover a large spectrum of people, able, old, young, disabled etc etc 41 Generally the design is good with additional lawn and trees. However I would suggest: \* Instead of ornamental plants to plant edible plants and for new trees, chose fruit trees and/or native edible plants and trees. Flowering plants to attract insects and butterflies. \* Too much use of red bricks and paving which makes it look very hard. Instead to use more softer material like wood or cream coloured material like sandstone/cladding. \* Sustainable garden beds like Wicking beds. Solar powered slights and lighting. \* Allow local community to maintain the garden beds and plant edibles and herbs or whatever they chose. 42 Previous grassed area around the flagpole was tracked and never grew. Muddy in the wet and dead in the summer. I would not reinstate this. Need a non-reflective hard wearing surface to cope with pedestrian foot traffic I don't like the proposed catenary lighting. It looks cheap and like a country side show 43 No costs are advised, which is pretty poor. I think money could spent on improving council enforcement of illegal parking and monitoring private building projects in the area ie increased council parking rangers and building inspectors to be on the ground in the area. The public space/appearance of the centre was ungraded several years ago and I don't know why money needs to be spent on something that is still very contemporary and not in need of repair or restoration.



44 We love the upgrade plans, but are not a fan of the fixed seating in front of the cafes. We enjoy the outdoor dining at the cafes and if those seats are placed there we will loose the cafe seating. We need to try and support the local businesses as much as possible. They are the heart and sole of the centre. See comments in file below. The Centre does not need these major changes - it is a waste 45 of ratepayer funds. Grass tends to require regular watering and maintenance especially if it encounters heavy 46 use. Looking at the grassed areas around the lighthouse development in Dee Why for example those areas become run down fairly quickly with bare patches and weeds invading them. Perhaps a harder wearing environmentally friendly approach is required that needs less maintenance and looks attractive without suffering from heavy use wear and tear. There's no information suggesting any storm water retention is planned to offset water use on the site. Due to our propensity for drought I'd suggest that this is needed to ensure gardens can be maintained any any water features on site can be maintained under water restrictions expected in future years. 47 To Sir/Madam, I find that the new bins (10) in front of kids paradise could be moved elsewhere as other parents and I enjoy sitting there as we wait for our kids in the toy store to choose their toys. We chat there and place their bikes there because it is a convenient spot. Is it possible to move that to a different location to preserve the convenient spot? Diagram 4.1 indicates trees marked as 1 in the diagram are to be retained. 48 The roots of those trees have caused the paving to lift and created a slope towards the shops making another obstacle for the disabled getting fron the two disabled car spaces. They should be replaced with trees that do not interfere with the pathway 49 The council for some reason moved two disabled parking spaces out onto Darley Street. for we people who use walkers the pathway around to the main shops is getting more congested each time i park there . It is now full of table & chairs ,plus the every increasing table with the produce of the bread shop. The trees have lifted the pavers making the paving sloped in towards the shop fronts. In wet weather there are large pools of water making the area slippery and dangerous. It is very difficult and dangerous to reverse into the spots . when one is parked and with a shopping trolley with a number of bags the slope from the rear of the vehicle down to the road makes it impossible (for disabled) to keep the trolley adjacent to the boot of the car . NB I have lived in Forestville since 1968 (see attachment 4) 50 the current toilet in the car park has been disgusting any time that i have gone to use it. what provision will there be for frequent cleaning? 51 Proposed plans look great and will really enhance the existing pedestrianised area. Catenary lighting will modernise the space and create 'laneway' style vibe. Toilet block essential. New paying stones essential - a number of payers are currently loose and pose a trip hazard. Curved timber seating proposal looks appealing. New Memorial essential - ensure it's designed so kids can't climb it, as currently happens. 52 Think the building of the toilet block needs to be fast tracked as it is long overdue 53 Support improvements and retaining existing trees with the exception of Triadeca sebiferia ("Chinese tallow") trees. Triadeca (aka Sapium sebiferium) are invasive, non-native species and should not be retained. This is an ideal time to replace these non-native weedy species with sustainable trees, such as Eleocarpus or other locally relevant tree species.



54 DRAWING 4.2 There are FOUR places in the mall where there are discontinuous awnings. 1. On north side between Coles and Blooms. 2. On the west side of the former Bakery / on the east of the central grassed area. 3. On the south side from the Medical Centre to McGraths Real estate. 4. From the north side of the mall to the south side. All of these situations are particularly annoying especially for older people and gaps of cover means that both customers and goods get wet. This is a put off for some and leads to customers choosing Forestway Shops or Glenrose where they can shop and NOT get 55 Excellent ideas. Fully supported. 56 The overall concepts as shown in the diagrams are appealing. Having rest spaces for shoppers and some grass area for soft play for children are good. The idea of a central column of seating and gardens etc. is ok but make sure there are enough gaps for shoppers to access both sides of the retail areas. We do need a more accessible toilet block. 57 I feel that a permanent toilet block is essential. Is it possible to somehow incorporate one of the many empty shops to lessen the impact on the carpark. 58 The toilets are required as soon as possible. The current lack of multiple toilets for both male and female is totally unacceptable. The toilet facilities MUST be built as soon as possible - NOT just "sometime in the future". They must be in a more central position NOT just "in the carpark". The toilets must be well lighted so it is safe to use at night. TOILETS are part of an integrated approach to the redevelopment NOT just an afterthought. 59 I wrote earlier about the grassed centre becoming a mud bath in wet weather. Maybe a small pavilion / gazebo could be added for the wonderful performers / musicians who frequent the centre. Car parking is always difficult outside the community centre, and would become worst during construction. A new toilet block would be a vast improvement, as once the community arts centre is closed there isn't much else. Wouldn't ever use that Exeloo thing myself. 71 Love the proposal of a grassed village green type area. A real gathering area. The placement of the current memorial has always prevented this area being properly utilised. so it will be good to get rid of that. If some kind of memorial is seen as being required, perhaps it could be a garden bed or tree with a plaque at the base. The area is very hot in summer, so the replacement of the hard bricks with the turf will make a huge difference. Perhaps local groups could take some responsibility for caring for certain garden beds by assisting with maintenance. A deciduous tree would be the best choice, so as to allow the much needed shade in the summer and sun in the winter. The whole area definitely needs suitable trees in the area to provide shade and ambience. The current eucalyptus corymbias do not provide this and pose a risk of branches shearing off. Replacement of the ones on Darley by ones with a broader shady habit would enhance that entrance. -Rather than the proposed circular seating, small individual tables/barbecue tables, etc would work better. People usually look for somewhere they can sit and chat with friends or by themselves and always look very awkward perched on those communal seats. They might look attractive but they are not what people choose to use. If the current trees need their growing area increased, then that should be done. The French cafe that used to be on Darley, had a wall of plants which looked amazing. It would great to see more lush greenery included in the plantings - a tropical feel. 72 The proposed planting list is not provided but I would like to see the use of all native plants for any new plantings. I would also like to see a water refilling station be included in the design. Centre needs revitalising and better toilet facilities are desperately needed.



74 This centre desperately needs a facelift. It is old, unattractive and with the modernised Glenrose not far away, it is losing patronage. There is nothing redeemable about it right now in what is an affable suburb. As the parent of young children, I won't go here if I have the children with me due to the inadequate amenities block (used by tradies & usually left in a vile state). Please consider updating it as part of the landscape update. No one will mind losing a few car spots if we finally get a decent amenities block! I woud not spend money in this design as no difference... 81 The new memorial structure on a raised plinth without seating (unlike the current memorial) is a good idea, as long as it is also dedicated (like the current one), incorporates the existing plaques which must be refurbished, includes a flag pole, and is lit at night. 82 It's Great, Thanks 83 Can the leased outdoor seating areas be shown on the plan. Without this detail, the plan is incomplete and potentially misleading. Why no artists impression of the eastern end? I really like the idea of the grassed area (detailed plan 4.2), but it will not work. Pedestrians will take shortcuts over the grass at it will soon mostly be dirt paths, not "lawn". This grass will need to be enclosed on 3 sides to prevent transit over the lawn perhaps some inward facing benches forming a continuous barrier on the west and north sides. If you get rid of the lawn, please put some shadecloth in this area - it can get hot with the concrete. "Shrub and grass underplanting" in the raised beds is not what is shown in the artist's impression. The plants selected by the artist (looks like a monstera) looks better. Existing brick paving and new bollards needs to be extended to the concrete path in the west car parking area between the centre and the library. Similarly, the brick paving needs to be extended into the laneway next the the post office leading to the library. Why does the catenary lighting not continue east in front of Coles? Isn't there already toilet facilities in the car park? I like the existing "auto" style more than a "toilet block", but perhaps there is room for another "auto" toilet somewhere else as well. Is there maintenance problems with this existing toilet that you want to get rid of it? Perhaps a single seat is insufficient capacity? PS Do not be tempted to put any permanent public art into the Forestville Centre. 90% of public art is rubbish. Perhaps some temporary art, with a vote to keep or chuck after 12 months, or rotate it from centre to centre so we don't get stuck with what the arts industry can flog to us.



- Already it's hard to find a parking spot during peak times which can be from 8.45am right through till 6pm on weekdays. Can we please hold on the number of car parking spaces we have and not take any away and rather add some more if we could. Perhaps build a multi storey car park or a 2 floor car park. This would really help the community. There are already toilets in the library building which should be enough.

  I like the thought of widening the garden beds and adding a row of lights in the Centre. Lights have such a lovely effect at night and make you feel like you're on holidays. A grassed central meeting area sounds great too. Maybe install a small children's playground like they have at the Killarney Hts Tramore Place shopping area so that families can gather and chat. More bins would be great too. I have to walk out of my way to throw things out when I'm at Coles. Bollards are a good idea too. I look forward to the planned improvements.
- WE MUST HAVE A TOILET BLOCK!!!!! This would be a priority over and above any landscaping.

Landscaping - who maintains these? - the gardens always looked neglected and uncared for and I know that some shop owners take it upon themselves to maintain these. In the proposed image of the "central lawn area" - remove those ridiculous looking tall poles - these serve no purpose whatsoever - put that money towards the toilet block! Who will maintain the lawn area? The same people who currently don't maintain the garden beds?

I hope that there is some funding to fix the uneven tiles throughout the entire strip - quite dangerous. The new images show an even ground so assume this is the case? Why have the "No Skateboard" signs been removed from the images - these signs state that "penalties apply" but I have never seen a Council ranger monitoring this in Forestville shops. Please do that as skateboarding is rampant there, especially in the afternoons. Why have the signs if you don't monitor this?

It would be nice to have a more attractive and useful centre - but not before you put a toilet block in. If you are not putting a toilet block in now, please leave the Library building open for longer hours so the toilets there can be used - especially now as summer is coming and some shops are planning on late evening special dinners - like the Brunch Bar on Thursday nights. When there for dinner - where are we expected to go if a toilet is required? Thank you.



#### 86 | Pros:

Extra seating and greenery is great and catenary lighting will boost atmosphere. Improvement/addition of communal gathering spaces good too.

### Changes:

Any new planting should be with natives, ideally local native flora. This will encourage native birds and support the local natural ecosystem.

The new design should make it easier for hospitality businesses to have outdoor seating, not impede it (but concept design seems to impede this with large planters and benches to break up spaces).

Some new bench seating and lighting poles make the spaces cluttered and difficult for adaptive use - try to declutter and think about people flow more. The spaces need to accommodate both thoroughfare and lingering.

The main central gathering space in particular could better accommodate the option of being a performance space, so having an open central lawn with seating and trees around the W, N and E perimeters should allow for this, not impede it too much. Can't see benefit of having two light poles right next to each other.

While gathering spaces are an improvement, the areas at the far ends where the mall meets the road are somewhat dead spaces/not that pleasant - more could be done to turn those into attractive gathering spaces in their own right, perhaps by giving them a more enclosed, intimate feel (rather than the exposed, harsh places they are now).

Would be worthwhile to add a few spaces that expressly cater for people with limited mobility to park themselves easily alongside other seating. Equally, bench seating can be challenging for older or less mobile people, so some hand rails/arm rests in some spots would be helpful and make the space more inclusive.

The whole area must be clearly non-smoking and this enforced - having smokers and cigarettes floating around is a massive detraction.

- Get rid of the dangerous 90deg parking adjacent to the pedestrian crossing in Starkey St. It impedes traffic flow and should never have been permitted. Also it is all very well to upgrade the Fville shopping precinct but there is insufficient parking already given the peak school demand.
- The project's objectives are not very clear. The new design is pretty much a repetition of the existing?

The design does not seem to improve much on:

- urban island heath (new pavement is darker than the existing one)
- water discharge new pavement does not seem to be water permeable
- light pollution at night street lamps should disperse and direct the light downwards only
- existing brick planters rarely work as benches, the surface is prone to catch dirt and does not seem inviting to most people (spend some time observing the place) timber or concrete seating tops should be installed if it is council's plan to promote outdoor seating there.

On such projects, the council could, as a policy, engage designers skilled in environment improving principles - heath reduction, water-smart design, application of upcycle materials, crafle-to-cradle ligecycle of material etc., there is plenty that an environment-sensitive approach can improve on such a project. The proposal does not seem to do the job. The concept design does not speak about any of these environmental points.



89	As a business owner in the centre we are very excited for the new development and
	upgrade to the centre. The plans are beautiful, our only issue is the fixed seating proposed for the planter boxes in front of the cafes and the widened planter boxes. This area is essential for the operation of our business, and the addition of the fixed seating and widened boxes will effect all cafe/restaurant operation.
	We applied and pay our for outdoor seating area which is essential for our business. The outdoor seating is a draw card for the centre as alot of our clients enjoy to dine alfresco. If the seating is added to the planter boxes as proposed, we (the cafe owners) will lose alot of our trade and council will lose the income from the outdoor seating permits.
	The toilets are a must, as alot of the community complain about the the current toilets and the other issue within the centre is the slippery nature of the pavers. There has been a number of accidents due to the pavers.

Spin the plans around now and reallocate the budget to current needs - it's not rocket science and not only about making it a pretty landscape - sorry but seems more about that than anything that the community wants or needs. It's a landscape concept and not anything to do with improving the centre. We are all surrounded by trees and grass at our homes.

  - 6. There is no shade provided, so not inclusive to the community at all and no one will be sitting in that area for more than 5mins during hot weather or rain.

- 1. The brick garden bed design could potentially now be non-compliant with social distancing regulations if needed to be exercised.

There is already a bottleneck at this end of Darley st, with kids, prams, bikes and skateboards all competing for space. Maybe the widened garden beds could be near the grassy area only, and not near the Darley st carpark. I am concerned that widening the garden bed in this are will overflow people onto the carpark and in the disabled parking spaces. Agree we need a proper toilet block! 145 Toilet block is essential in the Forestville shopping centre IT SHOULD NEVER BEEN TAKEN AWAY. 146 Looks to me like a waste of money fiddling around at the edges and making no real changes to the actual amenity of the area much beyond what is there. This looks more like maintenance and repair of what is there than any real plan to improve the area. A bigger picture view with more style and substance would be good. It could be a great pedestrian mall and deserves a better longer term plan 147 Need to be cleaned regularly but such a large Centre requires good toilet facilities. 148 Area desperately needs the sort of upgrade proposed. Make sure there are plenty of convenient bike racks. 149 Overdue as the volume of foot traffic has significantly increased together with dining operators. 150 The residential areas of Killarney Heights and Forestville do not have pedestrian walkways on most of its streets. It would be good if this were addressed for safety reasons as a priority. 151 Ensure brick paving is maintained properly. When bricks/pavers are not flush with surroundings they present a tripping hazard - many elderly frequent the area. Build toilet block soon please. Meanwhile, when the library building is closed we have to use the "kiosk" in the car park and its condition is often disgraceful. It must be properly cleaned at least once every day, preferably more often. It would be good to have at least two, preferably four, covered crossing points from one side of shops to the other so one can escape rain. Something must be done about the lane behind the south side shops where bins overflow and the area is mostly pretty disgusting. The toilet block should be the first priority. Given the number of shops and cafes, not 152 having a permanent toilet seems odd. The exe toilet is really unpleasant to use. 153 Excellent changes, love the random light poles, not sure about the overhead catenary lighting, suspect they will be a continual maintenance issue. Personal preference would be to put floor wash lighting in the new planter box bases. The lawn in the centre is going to be problematic, thousands of people track from Coles to the rear car park and when the lawn was there previously they wore the grass to dust in a very short period. I urge a rethink about that option. Is artificial lawn an option? As for the toilet block, absolutely replace it asap, the current capsule toilet is only used by people with absolutely no other choice. 154 Wonderful. I love the garden beds with wide retaining walls to double-up as seating. Is it worth making such changes if really, a large scale rebuild is in order in the future. The centre is outdated and the finishes grow old which is evident when you visit the space. Is it worth spending money now if in reality, a knockdown of the centre and development of a new commercial area is most likely to follow in the future. 262 There are more important things to spend money on, such as pavements. Re the toilet block, there are ammenities in library block during the day. I fear it may become a gang hangout in the evening It depends which car park. Underneath would be hard for elderly people who aren't very 263 mobile 264 The toilet block could be moved to a less conspicuous place than its current location if it is clearly indicated with a sign in the Mall area. It is not particularly pleasant to walk past the current cubicle on our way to the shops. Apart from this, I have no objection. 265 The proposals seem to reduce the circulation space. There is no need to increase the size of the planters. A 'green space' would be ridiculous. It would be a quagmire in two minutes flat! It would be difficult to retain the brick paving if too much work were to be undertaken. With more and more empty shops what is needed is a plan to attract more businesses. As long as a toilet is provided I don't think it matters if it stays as it is or becomes 266 permanent. 267 Realistically the Centre needs a major facelift and more alfresco seating for the eateries to give it a better vibe in the evening. Obviously understand this is difficult due to the individual ownership structure. This is a good improvement - the lighting and greenery will make it more enticing for people that choose to come and eat there in the evening. If you are removing the existing marble War Memorial structure to replace it with a new one then we have use for the old one at Aquatic Reserve where we would happily recycle it at the base of our flagpole in front of the Manly Baseball Clubhouse to reflect the links to the Frenchs Forest Soldiers Settlement. 1. With the high number of retirement villages nearby I'd like to see an AED unit similar to the Council installation in Melwood Oval to support the community. 2. Current Paving can be slippery when wet, it would be great to see non-slip paving 3. Drains in the paved area of the Centre get really smelly and are a turnoff when dining. 4. Alcohol consumption prohibition signs expired in 2016, 4 years ago and should be 5. Riding of bikes, scooter, skateboards etc. should be prohibited through the Centre, especially for the safety of the many elderly residents of the area. Dedicated bike racks may assist in this. 269 Ensure correct native trees are chosen to provide shade in summer and habitat and food source for native animals. The toilet block would have to be regularly cleaned and patrolled to avoid vandalism. 270 Sounds good, please do. 271 I support the upgrading of the landscaping to the centre and I totally agree with an improvement to the lighting however if it were possible to install fairy lights throughout the area it would provide a more festive atmosphere rather than stark pole lights. It would be welcoming encouraging more use of the area during the evening with increased greenery having the same effect both day and night. 272 Suggestion for circular seating - instead of wood which will require maintenance, look at a Mod Wood or Eco wood? The permanent toilet block adjacent to the carpark is essential for the community and needs to be opened sunrise to sunset. The current Exceloo is dirty and smells and is not an option I would use.



273	In my opinion the quality of shop fronts needs better control, rather than public areas. Changes look minimal and don't look like they will make much difference. Grass looks nice, but will it be able to grow well and be maintained. I am sure a lower maintenance solution is possible.  Look like this is focused on day time use. It is popular and has the opportunity to be even better as an outside dining space. This looks like it will reduce the cafes/restaurants ability to offer outside dining. Understand only graphic representation but lights look for show, rather than functionality.  Agree with nice toilet in car park, PLUS trolley return area.  Suggest the car parking under Coles is given serious consideration as part of plan, currently dark, damp and uninviting.
274	I think it's important to have safety bollards in front of the parking areas that face both sets of shops on Darley and Starkey streets. In light of numerous recent accidents where vehicles have accidentally accelerated into shop fronts I think it should be a top priority. As it will no doubt happen again
275	It would be great to see the centre rejuvenated.
276	I am unhappy about only one thing and that is the removal of the phone box. The reduction in access to public phones in shopping centres is not a good thing especially in areas where there are nearby schools and there are a significant number of older people who may not carry a mobile phone.
277	great to see council looking to update this area, as it is looking tired and dated
278	I said no because I am happy with the way things are now. I gather from your plans that by extending the garden areas you will be preventing the various cafes from having outdoor seating which to me is part of the uniqueness of the area. However I would agree if that is not the case.
279	Don't use black bricks. Too hot in the summer for children and animals. I would appreciate this being taken into serious consideration.
280	If means removing parking spaces then i don't think it will be of any benefit
281	The building of a new amenities block should be a priority. The exeloo is disgusting and no one in their right mind would want to go in there unless it was an emergency.
282	I really like the plan for the landscaping, it's just what is needed. However, I would also like to see a safe clear pedestrian route between the library, and playground, through the car park to the Centre. Especially as this is where the toilets are commonly used.
283	Parking still is a problem, commuters also take shops parking.
284	Lawn area needs to be artificial grass. It was real grass many years ago - it gets to much foot traffic for real grass to survive. Love the circular wooden seats and lighting.
285	This has been needed for some time as the Centre is beginning to look its age.  Landscaping a good idea, and I would suggest a permanent toilet block sooner than later, present facilities are badly neglected.
286	It needs some sort of further cover to protect customers during both hot and cold and wet weather. When it rains it is impractical for people with kids and the elderly. Some higher level cover over the middle section will make it more user friendly all year round and later at nights in summer.

### Forestville Landscape Upgrades - Draft Plan

Watermark Planning provide this response to the Draft Landscape Concept Plan for The Centre, Forestville shops, as both an occupant of commercial property at The Centre, and on behalf of the retailer at 51 The Centre, Cocco Rocco Deli.

Both myself and the owners of Cocco Rocco are supportive of the plans for upgrade and renewal works within The Centre. We agree that revitalisation of this key local centre will be to the vast benefit of the local economy and the local community, who regularly use the facilities and services of The Centre. However, following our initial review of the draft plan, we have some significant concerns about the workability and fairness of some aspects of the Draft proposal.


We note that a combination of seating, paved areas and planter beds are to be utilised in the central strip of the mall. Currently there are planter beds, and many of the local cafes have seating which occupies areas of this central strip of the mall area. See the photo below of outdoor tables in use at Cocco Rocco Deli, with planter beds either side.





These outdoor tables, licenced by Council, add vitality and life to The Centre. They bring people into the outdoor space and provide the community character and atmosphere, which is what Council needs to encourage with any planned landscape redevelopment.

Looking at the proposed plan, and concentrating on the western end of the mall, where Cocco Rocco is located (no. 51), it is evident that the size of the new proposed planter beds varies, with no obvious pattern to the size chosen. Some planters are double the size of others. We are concerned that the location of the largest planter appears to be immediately in front of Cocco Rocco Deli and entirely within their outdoor licenced seating area, as seen in the photo on the previous page.



The result of this siting for the long planter bed will be an inability for Cocco Rocco to continue to lease the central outdoor space from Council. The assumed impact of this would be a drop in customers and income. It will also mean a reduction in activity and life within the central mall area, which is certainly a loss for not only this retailer but other shops at this end of the pedestrian mall.

We suggest that the choice for location of the planters is not well thought out, and has not considered the existing café and restaurant locations, as other existing cafes appear to retain the space immediately in front of their premises, and would be able to continue to use this for outdoor seating.

Cocco Rocco Deli has operated in this location for 10 years and are a key contributor to keeping The Centre shops vibrant. It is a busy retail deli, who have loyal clientele, including myself. They are a large part of The Centre, Forestville community, and a design which is to the detriment of their business, is not to the benefit of The Centre.

We request that when the Draft is revisited, that Council look at the existing retailers and the limited number who provide outdoor seating, and ensure that these crucial retailers retain ample immediately accessible outdoor seating areas to continue to operate as they currently do. We believe that any landscape design must, as a first step, map out the location of existing retailers and consider as essential that such outdoor seating areas are retained. This is particularly key at the moment, with COVID-19 making outdoor seating a preferred space for café customers to dine.

We are very hopeful that Council will continue to offer leasing of outdoor seating within the central area of the mall. As a part of this landscape design strategy, retailers and the community should be advised if the intention is to change the existing Council licencing agreements with retailers. Should this situation arise, Council must consider that this may result in some businesses becoming unviable. This is of particular concern, when the impacts for some retailers are a loss of space and others are not impacted. It is the responsibility of Council to equitability consider all cafe and restaurants in the mall and ensure that no existing long-term retailers are more detrimentally impacted.

It is essential that the next stage of planning includes all details of all existing leasing of seating and details how and if this will be impacted. A change of this nature would have a major impact for occupants and clientele of existing businesses. The community consultation process must be transparent and clear so that the community and retailers can make a judgment on fairness and consider how such a detrimental loss would impact on The Centre.

We strongly urge Council to redevelop the current design to a more equitable layout, which has considered existing long-term retailers. We welcome discussion with Council and are happy to assist should you have any questions regarding our concerns and the impacts on existing local businesses including Coco Rocco Deli.



#### Submission regarding the proposed upgrade to Forestville shops

In general, I am for upgrading and updating the Centre. However I have some significant objections to some of the proposed changes.

#### Lighting

The light columns - great, makes the place better at night.

Catenary lighting - might look nice, but I'm concerned about birds sitting on them and pooping on people below.

#### **Bollards**

p4.1 item 12 - bollards. Excellent idea. These also need to be implemented at the Arthur St, Forestville shops where there was recently an incident.

The current bollards at the Darley St carpark entry are too widely spaced to prevent an incident, so should be made closer.

#### Access

#### p4.2 Detail

The proposed bench seats outside shops 39 and 37 will impede access along that important corridor, and should be moved further north.

The rendition on page 7.1 is completely out of scale, and shows the access near (the previous) Ichiban restaurant completely broken.

#### Eating areas

The nighttime dining outside "Lucky and Peps" and also Thai Garlic is really valuable, yet I see no mention of it at all in this plan. Also, daytime eating outside the Deli, the Brunch Bar and many others should be taken into account in this plan. There is no mention of it, yet this is really important. This would be a great time to improve this important aspect of the Centre. I would really like to see consideration being made for lots more of this, especially as it provides an eating area that is safer regarding Covid.

In the renditions on page 7.2 and 7.3 I can see no consideration to this. All I can see is huge planters with no actual space for the actual eating areas.

I wonder if these shops were approached about their needs before this concept was created.

As the design brief includes "flexible spaces for socialising and connectivity", this appears to be a significant omission.

#### Lawn

#### p4.2 Detail

A lawn here is a terrible idea. There used to be lawn here, and the traffic and lack of sunshine in winter turned it into a dust bowl. Please no.

#### RSL flagpole

There's no explicit mention of it, but it looks like it's proposed to remove the flagpole and Returned Service members' memorial. Is this what is proposed? I think many would disagree with this (if it was known about). Is the "New memorial sculpture" a replacement, or something different?

#### Water bubbler

There is no mention of it in this concept, yet the "Placescore" report mentions the people were not happy with the lack of a water bubbler. A water bubbler / water fill station should be included.

#### Other issues

There is occasionally a foul smell that comes out of the drains down the middle, often near shops 8 / 35. The drainage system, storm water and sewerage should be checked and corrected as part of this upgrade.

#### Cost

I'd be interested to know what the proposed budget for this is. While some improvements would be nice, I fear that an excessive amount of money is being proposed to be spent on something that's not really that crucial.

#### "Have your say"

I was disappointed that this proposal was not included in the council newsletter of 20/11.



#### Resident feedback re Landscaping Improvements The Centre, Forestville

I have lived in Forestville for over 40 years and therefore feel I am well qualified to comment on the above, having seen many of the past upgrades to the Centre.

#### Positive points

- Improved and more modern lighting needed
- Bin upgrades need larger/more bins and more frequent collection. In busy times current bins overflow
- 3) Public toliet upgrade- yes please

#### Negative points

- We do not need central grassed meeting areas Some years ago there was grass around the
  war memorial in front of the TAB and was eventually replaced by the Council with a hard
  surface as its became a dusty, and in the rain, muddy with the excessive foot traffic. It was a
  mess and the current surface does not require change.
- Additional seating is not required but perhaps replacement of existing benches with a more modern style. The current seats work really well and the walls around the trees/gardens are very effective.
- 3) The current landscape/garden arrangements are low maintenance and are pleasing to the eye. We do not need widening of the current beds - also extra work will be required to maintain larger garden areas. Who is going to do this - additional work for <u>Council</u>?
- 4) The current open areas work well for the cafes and shops there is space for outside tables for lunch/breakfast/dinner and sipping coffee. Under the proposed plans much of this will disappear with the larger garden beds and additional seating which are not needed. Have the shop owners been consulted re this plan?
- A free public internet service needs to be there to attract foot traffic. Council did offer this service but it was never reliable and has now completely disappeared.
- 6) Looking at the concept design, the cost for the proposal will be significant with limited benefit. As a ratepayer, I object to these funds being spent on something that works very well now. Some reduction in scope should be considered required but I suspect the Council is already committed to doing this with a great deal already spent on the design phase. Did the Council get local input before proceeding to the concept design?
- 7) There needs to be a better mix of shops too many gyms, coffee shops and empty premises some of the awnings and shop fronts are in need of an upgrade. Appreciate this is probably beyond the Council's responsibility but it is something to consider as it will improve the ambience of the area.
- 8) If any work does take place, please ensure the current paving is <u>relaid</u> properly and not like the NBN instal. <u>Also</u> Council will need to co-ordinate with utility organisations to ensure there are not future works requiring future disturbance of the paved areas.
