#### 1. Summary

This report outlines the outcomes of community and stakeholder engagement as part of a proposal to improve the pedestrian access and amenity at the northern end of Mona Vale Beach.

Response to this proposal was largely supportive (72 percent) with most feeling that the proposed pedestrian and landscape improvements would improve accessibility and usability of the area.

Many also cited the proposed path should be extended further south along Surfview Road and that the shared footpath should be widened.

We also heard from those who did not support the proposed pedestrian and landscape improvements with majority of those comments raising concerns about the overuse of concrete in a natural area.



## 2. Background

Currently, the northern end Mona Vale Beach is unpaved. The upgrade plans to include a proposed footpath and a proposed grass area.

The proposal aims to provide a more cohesive visitor experience safely linking pedestrians and bike path users between local cafe's, Apex Park, Mona Vale SLSC, amenities and lifeguard buildings.

The path will also provide an important connection as part of our iconic Northern Beaches Coast Walk that will stretch from Manly to Palm Beach.

#### 3. Engagement objectives

Community and stakeholder engagement aimed to:

- build community and stakeholder awareness of the project and how to provide comment
- provide accessible information so community and stakeholders can participate in a meaningful way
- identify community and stakeholder concerns, local knowledge and values.

#### 4. Engagement approach

Community and stakeholder engagement for the Pedestrian and Landscape Improvements, Mona Vale Beach was conducted over a six week period, from 16 December 2021 to 30 January 2022.

The engagement was planned, implemented and reported in accordance with Council's Community Engagement Matrix (2017).

The project's impact level four Community and Stakeholder Engagement Plan was devised on a single staged approach.

A project page was established on our have your say platform with information provided in an accessible and easy to read format.

The project was primarily promoted through our regular email newsletter (EDM) channels.

Feedback was captured through an online comment form embedded onto the have your say project page. The form included a question that directly asked respondents for their level of support on the proposal.

An open-field comments box provided community members a space to explain or elaborate on their support, not support or neutral sentiment as well as any other feedback they wished to contribute.

We also invited comment through email.

## 5. Findings

Feedback received was largely positive with 72 percent of those who answered the direct sentiment question indicating that they supported the proposed pedestrian and landscape improvements.



Respondents who were supportive indicated that the upgrade will provide better and safer access to diverse members of the community including benefit to the local elderly population as there are multiple nursing homes nearby. Comment of support included:

"This concept is fantastic and will accommodate the increasing foot traffic at mona vale beach".

"I am very happy with all the new work being done at Mona Vale Beach. The architecture is tasteful and the materials used are sensible for the marine environment".

"This is a great upgrade to an area that is currently not easy to walk through".

Many also cited the proposed path should be extended further south along Surfview Road and that the shared footpath should be widened.

There were many respondents who indicated that if Council adopted a more natural designbased approach, they would be supportive of the project.

While direct sentiment indicated support for the proposal, the additional comments collected during consultation from residents were largely focused on concerns and potential issues of the additional concrete proposed in the existing natural area.

There was also a strong desire to maintain the natural aesthetic and landscape in these comments. Table 1 and 2 below respond to key issues and questions raised.

Overuse of concrete	Community members have concerns about the overuse of concrete.	The width of the concrete path has been reduced. Concrete has only been used where necessary to provide safe access for pedestrian movement and reduce ongoing maintenance interventions and cost burden.
Maintain the natural aesthetic	Mona Vale Beach's natural aesthetic should be maintained including the vista unencumbered and replan the fencing.	Natural materials such as sandstone, turf, deco-granite and mulch have incorporated to maintain the natural aesthetic. The timber picnic tables and seats will be rejuvenated and reinstalled.
		The existing 2 rail dune fencing south of the amenities with the flat rail will remain in place. The dilapidated 3 rail dune fencing will be replaced with a lower height 2 rail system to match the recently installed dune fence along the S.L.S.C. building.



Design	This same area was previously grassed and destroyed by the natural elements and another attempt to turf the area will be a waste of money.	The raised turf area will assist in preventing windblown sand covering the area and also reduce pedestrian foot traffic impacting the turf. 4	Looks good. However do not know why there are ugly pine trees which are not native
5	Cognisant of the effort to keep or improve the green areas, the amount of concreting proposed is still astonishingly overwhelming. Concrete pathways are a disgrace and will end up (i) creating erosion consequences in nearby areas, (ii) increase the thermal mass of the area instead of absorbing or dissipating the heat, (iii) further destroy the natural landscape and push the urban aggression of an already tasteless suburb.
	Too many pathways to the beach, not commensurate with the actual size of the beach goers crowd. The whole area should be motor vehicle free and parking removed to the urban side with proper pedestrian and cycle paths crossing.
	Back to the drawing board to design a truly natural and harmonious place rather than an extension of the city
6	The proposal looks great from the sketches. But as the "current" photos show,
	Council went to a lot of time, effort and money to turf this very same "surf side" area previously only to have, in a matter of weeks later "a South Easterly" literally blow hundreds of tonnes of sand off the beach and onto the brand new turfed areas killing all the new turf literally within days. Hence it's current appearance. Having turfed areas for people to sit and have their lunches etc. is a great idea, but with the plans must include some sort of barrier to stop the bulk of wind blown sand from getting to this point. I have also noticed there is also no reference to watering provisions noted. Storage tanks for rain water run off from both the club house, amenities and car park would be a great idea that can be used for watering the turfed areas and would ctually be a saving in the long term as this was the starting point with the "failure" of the previous attempt at turfing these areas.

All of my neighbors want a nice affordable restaurant which we will use regularly. There is no better view of the beach and ocean and we would live to be able to enjoy the new facility
21	Path looks great and will be so much safer and more accessible, however this area is frequently covered in sand drifting from the beach / since the council lowered the sand dune the last time/ need much more attention to dune stabilisation otherwise the new path will be covered in weeks.
22	Make the path at least 2.5m wide to cater for our high volumes of dog walkers, cyclists, prams, joggers and walking groups that use this much loved promenade.
	Once the path reaches the Surf Club, continue it over the grassed area behind the dunes and all the way on the eastern side of Surfview Rd south. Around the outside bulb of the cul-de-sac and join to the coastal walk as it continues south along Mona Vale Golf Course. This extension will keep 95% of coastal walkers away from vehicles doing the 'cannonball run' down Surfview Rd cul-de-sac trying to avoid being blocked by vehicles that have followed them into the one-lane in-out laneway. 	That area has been grassed a number of times over many years, first by Warringah Shire Council and then Pittwater Council. Each time it has failed with the grass being covered by sand blown over it in southerly gales - the area faces directly into the wind from that direction. The proposed path is unwanted as it furthers the over development of Mona Vale beach - the concrete bunker recently built on the point and over-sized function centre overlooking the beach are ugly and overbearing from every aspect.
27	The protection of the Norfolk pines root system is a number one priority. Maybe
	need to consider some additional measures to protect the root system such as low
	ring fencing or light stucture around the base if necessary.
28	Just worried that the grass area won't survive as the council tried that some time ago & within months it was covered with sand & all the grass died off.  Also council should consider extending this walkway south along Surfview to meet the path at the Mona Vale golf course with either a widened footpath or board walk or both as this area is a pedestrian nightmare on busy weekends just waiting for a bad accident to happen.  I believe council is already considering a solution for this area but it should be tied in with the above proposal.
29	I do support the. upgrades but do hope they are better than the recent upgrades to the change rooms etc. I totally endorse the new amenities block in Apex Park but why not another Amenities Block on the lawn south of the new surf club? There should have been toilets for the public in the new surf club. Also, I cannot see how the lifesavers can see ANYTHING from the new shower block area. The fence is in the way and I would have thought they would have had a vantage point from the roof. It is a lovely construction but my gosh there are such BIG flaws. Also, cleaning of the new shower areas etc is atrocious and not nearly as regular and good as when the council did it in the old block. I swim at the beach early morning every day but can no longer use the new shower blocks because of all the sand and general lack of hooks. These are things that can be fixed.
30	I am a regular at Mona Vale Beach nearly every day. I have seen grassed areas tried in the past and within a few months it turns back to sand and dirt again as the areas are not maintained. Either there needs to be regular maintenance and watering of the grass (automatic watering system?) or just leave it as it is.

	1/The turfed seating platform.  There have been several past attempts at establishing turf in this vicinity, all of which have failed due to lack of watering, sand incursion from the dunes and beach and the impact of heavy human traffic.  The new turf around the recently completed amenities block is already showing signs of stress as no watering system was included and traffic is high. I'd assume the turfed seating platform will have less traffic, but at the very least a watering system is essential to its' ongoing viability.  2/ Removal of existing tables and chairs.  Currently there are at least two sets of picnic tables and benches in the proposed turfed seating platform area. It would be great to include these type of picnic facilities in the new plans. The two covered picnic facilities to the north are heavily used as are the existing tables in this area, so additional facilities would be greatly appreciated.
	3/ Additional Picnic facilities/ Viewing platforms. Raised viewing platforms in the dune area similar to those at other beaches and at Surfview Road should be considered for the dunes east of the turfed seating platform. They could also include a picnic table.
	4/ The plan doesn't indicate what if any surface is between the turfed platform and the dune fence. It looks like this may continue to be regularly used so consideration of a durable surface would be worthwhile.

68	The sensible and user-friendly landscaping of this areas will complement the new SLSC building and northern amenities/lifeguard facility and allow safe and comfortable pedestrian access between the two, and importantly from carpark to beach. An elevated grassed area is best given this area is subject to sand dune blowout during storms and high pedestrian activity - it should also be drought proof.  I would suggest the following:  1. The main concrete footpath should be as wide as possible without impacting the Norfolk pines. Crushed granite paths have failed in the past as they were either not maintained, become uneven /eroded or covered in sand - they are also uncomfortable for barefoot pedestrians accessing the beach.  2. Concrete should also be considered for the secondary pathway near the dune
	fence for the above reasons.  3. The concrete pathway near the NE corner of the new SLSC building should be widened to allow pedestrian flow between the proposed café area and dune fence - this was a bottleneck previously with customers waiting for orders and pedestrian access.
	4. A redesign of the reserve area dune fencing should be considered. They should be strong enough to support seating without damaging the vegetation and also possibly have a layer of erosion proof geotextile fabric to control sand blowouts during major ECL's and storm events (this area has been turfed and grassed in the past only to be subject to drought or covered in sand).

Using a bike bell from behind a pedestrian usually isn't heard especially when there is traffic noise. time for pedestrians to be able to walk safely and without fear in public areas. If bike riders are on the footpath and there are pedestrians they should be dismounting after all cars are legally obliged to stop and not beep their horns at pedestrians.
