### 1. Summary

This report outlines the outcomes of community and stakeholder engagement conducted between 5 August 2021 to 5 September 2021 as part of a proposal to upgrade Jacka Park Playground in Freshwater with inclusive, fun and challenging play equipment for a range of ages and abilities. The proposal also includes upgrades to landscaping, seating and paths.

The feedback collected during consultation from residents, parents/carers and children indicated a majority level of support for the proposed upgrade of Jacka Park playground. Respondents who were supportive of the proposal indicated that it would benefit the local children who use this playground daily.


Feedback suggested that, to make it as beneficial as possible, the upgrade should include more playground equipment for children of different ages, needs and abilities. There was also a strong desire to upgrade the entire park to provide more facilities for intergenerational and recreational use.

Some respondents who were not supportive of the proposal felt that Council should not be spending money on an already established park when there are other projects to prioritise.





#### 2. **Background**

Jacka Park playground is a historical, popular and much-loved playground in the local community.

Jacka Park was named after Blanche Jacka who was granted use of the wild and swampy land across from her house on Wyndora Avenue to make a garden in 1917.

The playground design will be inspired by the native plants and animals that once flourished in the area, including Mrs Jacka's favourite flower: the crimson bottlebrush.

#### **Engagement objectives** 3.

- Objective 1: build community and stakeholder awareness of participation activities (inform)
- Objective 2: provide accessible information so community and stakeholders can participate in a meaningful way (inform)
- Objective 3: identify community and stakeholder concerns, local knowledge and values (consult)

#### 4. **Engagement approach**

Community and stakeholder engagement for the Jacka Park Playground Upgrade was conducted over a four-week period, from 5 August 2021 to 5 September 2021.

The engagement was planned, implemented and reported in accordance with Council's Community Engagement Matrix (2017).

A project page<sup>2</sup> was established on our have your say platform with information provided in an accessible and easy to read format, including an image of the draft concept plan and some historical background.

The project was primarily promoted through onsite signage, resident and stakeholder notifications, social media and our regular email newsletter (EDM) channels.

Feedback was captured through an online comment form embedded onto the have your say project page. The form included a question that directly asked respondents for their level of support on the proposal.

An open-field comments box provided community members a space to explain or elaborate on their support, not support or neutral sentiment as well as any other feedback they wished to contribute.

Email and written comments were also invited. Contact details for the project manager were provided as a channel for the community to ask any questions about this project.

## 5. Findings

The feedback collected during consultation from residents, parents/carers and children indicated a majority level of support for the proposed upgrade of Jacka Park playground. Respondents who were supportive of the proposal indicated that it would benefit the local children who use this playground daily.

Currently, Jacka Park Playground is overpopulated after school hours and has equipment for younger children only. Feedback suggested that, to make it as beneficial as possible, the upgrade should include more playground equipment for children of different ages, needs and abilities. There was also a strong desire to upgrade the entire park to provide more facilities for intergenerational use and recreational use.

A large majority of residents were supportive of the design concept to include references to local flora and fauna as a major feature of Jacka Park Playground.

Some respondents, including both caregivers and local residents, who were not supportive of the proposal and felt that Council should not be spending money on an already established park when there are other projects to prioritise.

1	Please keep the sitting/border wall to the playground for parents to sit & social distance but still be close to their younger children while they are playing. It has been a great asset during these restrictions to feed my younger son and be able to watch my older son play safely using the wall.
	Please keep the track/path around the playground for bike riding/scooter riding.
	Please keep some bridges within the play equipment and wheels to spin (car wheels/wheels on the train have been a favourite for my boys) within the new design.
	Please add more swings. 2 toddler swings and 2 child swings would more often allow 2 families to use them at the same time if both had 2 kids or 2 sets of playdate friends. 3 swings is an odd number, even with the special swing shape.
	If it allows, small trampolines like at the Tramshed Playground in Narrabeen are also a favourite for younger kids.
2	I am supportive of the improvements to Jacka Park. In addition to the changes suggested in the plan, I think the park could have increased use for all residents, not only families, by two additions. One being the introduction of an adults gym area. There is no adult gym equipment in freshwater and the closet one at Queensliff Lagoon is fully utilized, particularly with the current lockdown and that people will be working remotely for a long time. An additional picnic table would help with picnics and parties and take pressure off the 3 or 4 picnic tables at Freshwater beach.
3	It would be completely amazing to see a basketball hoop area which is great for the 10-12 year olds. My 2 children also love playing soccer at Jacka and would love to see a soccer net down there. We see it as a great way of getting our 10-12 year olds outside away from screens and would love a basketball hoop and soccer net. We don't have a suitable driveway area for basketball so it would be awesome to send them down the street to the park to do this. Thanks so much for considering this as a possible option. We appreciate it. Thanks
4	It would be great to include one of those big, flat swings which holds several children and hangs from a single point. There's one in Forsyth Park playground in Neutral Bay. Thanks!
5	No dogs. There have been too many incidents and there are a number of other more suitable locations for us to take our dogs. Children with unfamiliar dogs don't always mix well - and vice versa
6	- My only suggestion would be to enclose the playground space with a fence. Currently, with the bike path surrounding the playground area, it can be dangerous for kids and parents as they move around the area. Particularly for young children as they go through the current entry way which falls directly onto a bike path which is the base of a steep incline, hence kids that are on bikes are at speed.

The proposed plan is going to improve the play area to further the physical development and interaction of the local children and their visiting friends. I think that perhaps additional seating for the parents may be worth considering, as many of the children don't like to leave the play area and the other children, especially now with unit living being the focus of Governments and more people will be using this great facility in the future. So do the best you can for the future needs of Freshwater.
18	There needs to be activities and equipment for children aged up to 12. 'senior' is not 4 and upwards. Jacka park is used by primary school children of all ages after school in normal -not covid times. Leaning into this natural demand and behaviour, could this be made more 'official' by creating small tabletop mounds and berms allowing them to ride around the entire perimeter of the park? There's no need to create an entire track, but rather a series of features that kids will naturally link together on their bikes. Like the manly dam track, it could be encouraged to be used in a specific direction, and being on the periphery would X-ray a low cost attraction that separated bike riders from pedestrians safely.

	Re the above & request for submissions, I hereby would like my ideas & serious concerns to be taken into consideration in regard to the future upgrade & for the habitat & co-existence of users of the park, which include area wildlife, bird habitat, treescape of a park & surrounding area/s.



Working daily next to the park & observing critical problems unfolding, I have on three separate occasions voiced concerns, twice direct with council workers, & thirdly contacting Council in respect of those concerns.

Therefore, hopefully some basic but critical problems can be fixed.

1. Critical need for tree surgeon to do survey, implement action plan to stop the on-going destruction of the park trees due inexcusable use of whippersnipper trimming being used around the base of the park trees.

It is totally destructive to the trees. It is allowing borers, infection to Damage the trees, which now show considerable decline to their health.

My husband & I have, over the years, worked in bush regeneration & it is very disappointing to see such a lack of basic awareness of tree & environmental protection.

My husband is an actual qualified bush regenerator through Ryde Horticultural College therefore it is very necessary now, for the trees in the park to be assessed, remedial action be taken, Bush regenerators hired to work with the gardeners to reach the proper outcome for health & safety of all trees in the parks on the northern beaches

Further, the need for the ride on mowers to stop going over the tree roots damaging same.

Mulch needs to be re-established around the trees. This was case a few years ago but appears to not be undertaken at present. The re-introduction of mulch would create a barrier for the trees, provide a barrier to moisture loss,

& lastly allow natural tree regeneration, which I have witnessed along the side of the major road within cracks of the pavement.

Please see attached photos, Jacka Park, & Curl Curl Reserve, where destructive practices have been allowed to continue, therefore the trees are having a decline of a thousands cuts until eventual decay & death.

There is also need for the regenerators to start planting new growth trees, natives, for street scape, the expected high temperatures & for native bird & wildlife habitat. I would also suggest that schools be included in a program to facilitate habitat & wildlife corridors, together with some sort of link for possums to safely cross roads, eg cables etc.

Further, there is a need for bird boxes, possum boxes to be established, high up, to provide necessary shelter & shade for wildlife, may be able to establish in schools & some parks, out of harms way.

As can be seen from the photos, the problems can be fixed & can be solved, With little cost or manpower, but are very urgent & necessary. The thoughts expressed apply to all our parks & recreation areas. There needs to be proper oversight of management of contractors. The cost in destructive practices is too high for us & our native wildlife & bird life.



I have worked at Jacka Park school crossing for a number of years & it has been very sad to see the decline in care & thought due to lazy practices undertaken just for a quick finish to a job. Hopefully full consideration will be given to the serious concerns raised.

There are hundreds of birds, of all descriptions, together with the sighting of ringtail possums that inhabit this one park, we need to improve & enhance the quality of that amenity, & for all recreation areas.

May also suggest some round bench seating to safeguard the trees, & for seeds to be taken from the stand of gums along Oliver Street, for propagating & to regenerate other parks together with also seeds to be collected from the huge native fig tree, which provides tremendous shade & shelter.

Thanks for your consideration of the matters raised & look forward to a favourable response.

Lovely to chat with you yesterday re: the proposed Jacka Park upgrade. I like the overall concept of catering to older children i.e. over 4 years. A few comments covering what we discussed yesterday:

- a) I agree that it is good to keep a large area of open space, as many parents and their children kick balls around in it.
- b) Can I suggest the removal of the baby swing near the entrance? Some teenagers swing it back and forth as forcefully as they can and it seems they are trying to break it!
- c) Replace current garbage bins with banks of garbage and recycling bins.
- d) Retain as much of the sandstone dwarf wall as possible. It adds character.
- e) Add signage directing people to the toilets.
- f) Construct a section of footpath (approx 30 metres long) on the southern part of Wyndora Ave (from Eric St to Jacka Park), so that parents with prams and children do not have to cross the busy Wyndora Ave. This will complete the footpath from Oliver St to the eastern end of Wyndora Ave.
- g) Repair the timber fence between Jacka Park and Glen St.
- h) Children about 8 to 11 years of age are building dirt jumps for their bikes in Jacka Park on the boundary of my property. I'm pleased they are doing this rather than be inactive at home, however it indicates that there is a dearth of purpose-built bike tracks for these children, such as the one at North Balgowlah. ### SUBMISSION ON UPGRADE OF JACKA PARK, FRESHWATER

4 September 2021

The Friends of Freshwater has long been involved with Jacka Park.

Our involvement over the last decade has been with other community groups such as the Harbord RSL Sub Branch; the Soldiers Avenue of Honour Stakeholders Group, Freshwater SLSC and the Harbord Literary Institute and includes: -

- The Formal registration with the State Government of the War Memorial as a Community War Memorial now known as the Freshwater Anzac Precinct. This Precinct also includes the heritage listed Soldiers Avenue of Honour. This is only the second war memorial to be so registered on the northern beaches.
- To coincide with the Centenary of Anzac in 2015 and the Centenary of Armistice Day in 2018, we gained funding support from the State and Federal Governments to commission two Commemorative Sculptures, cast in bronze, by renowned sculptor, Alan Somerville. This also included permanent seating and explanatory plaques. These form a part of the permanent infrastructure of the Park
- We have also received funds from Northern Beaches Council to hold successful commemorative events for these Centenaries.
- A decade long campaign to obtain adequate toilet amenities for the Park resulted in our concept of a Council workers shed being successfully converted by Council to a public toilet facility.
- Lobbying to upgrade playground facilities.

Freshwater, as a suburb, has been identified by Council planners as having, other than Brookvale, the least green space of any suburb on the northern beaches. In this context, Jacka Park is particularly prized as an open green space uncommitted to a particular sport or activity. Now, with the provision of public amenities, it has come alive as a picnic area for families with young children. The upgrade to the playground facilities will be much appreciated. It is also used by a nearby School as a passive outbreak area.

Our initial discussions with Council included the relocation of the current playground away from the Freshwater Creek pipeline overflow area. This was because the playground and



its soft fall was regularly damp, mouldy and unhealthy for children of a crawling age. It was thought that the playground would be relocated further up the Park to a relatively drier area. The current playground would then be modified to become an outdoor gym. These, in Covid Lockdown, are extremely well utilised elsewhere.

Disappointingly these concepts are not recognised in this Upgrade and given the pressure on Council to provide public amenities across the LGA are unlikely ever to be realised.

Our previous discussions with Council also included the provision of a further Shade Structure to complement the two existing Structures. Increased use of the Park by the community would make this a useful addition to the Park infrastructure.

We provide these comments for your further consideration.

#### Submission - Comments on Jacka Park upgrade Concept Plan

I am a Freshwater resident and mother of a boy aged 18 months. We have been enjoying Jacka park for the last year or so and are very happy that an upgrade of the playground has been proposed. We feel very lucky to have such big space close to us for our little one to use and explore and would love to mention a couple of things that are important to us when it comes to the playground's environment, play and gross motor equipment for our boy and all the children of the Freshwater community, big or small. Here are some of our comments:

- We love the idea of a garden of native plants and flowers within the playground space, it is both a beautiful way to link the space with its former history and to introduce our children to the native flora of our beautiful environment. It would be great if the garden was significant enough to attract native fauna too (eg if there were a 'lizard lounge'). We also wonder whether the garden beds could feature in more parts of the playground rather than being 'one-off', maybe in the form of a small maze for the children to explore?
- While we understand that safety is a big part of the planning when it comes to a playground, we wonder whether the council could take into account the ground surface materials used to provide this safety as well as the educational potential those materials might have for our little ones. While softfall might be the easy 'go-to' way of providing safety for our children, it is not a natural material and disintegrates over time. I have countless experiences of my child crawling around playgrounds that use this material, ending up covered in the small particles which stain his clothes, and trying to eat it. Softfall and synthetic turf both fail to give 'feedback' to the child from a pedagogical / learning perspective. As a pre-school educator, I know how important it is to allow our children to experience the natural environment first-hand, in order to understand concepts such as hot/cold, hard/soft, wet/dry, smells and textures. A far better material would be tan-bark. As a parent, I would rather my child put bark in his mouth and got dirty from the natural environment, rather than crushed rubber.

I have included some photos below of the challenges with softfall (especially as it gets older) and some photos from a beautiful park at Mungo Scott Place in Summer Hill, which you can see utilises bark to create a very natural environment.
